DOG REGISTRATION INFORMATION

- All domestic dogs over the age of 12 weeks must be registered with Scenic Rim Regional Council.
- Registration should not be confused with microchipping. These are two separate forms of animal identification.
- Microchipping of all domestic dogs is compulsory and a requirement when submitting this application, unless the applicant can provide proof of ownership prior to 1 July 2009.
- If the dog owner is claiming any concession/s, evidence must be supplied to be eligible for concession discount. (eg. Copy of current Pension card or desexing certificate)

- The owner of the dog/s must advise Scenic Rim Regional Council in writing within 7 days of any changes to the information provided on this Registration Application.
