Local Law	Purpose and General Effect
Local Law No. 1 Administration 2011	 (1) The purposes of this local law are to provide a legal and procedural framework for the administration, implementation and enforcement of the local government's local laws, subordinate local laws and specified regulatory powers under legislation, and to provide for miscellaneous administrative matters. (2) The purposes are to be achieved by providing for— (a) consistent and comprehensive processes for the local government to grant and regulate approvals to undertake prescribed activities; and (b) authorised persons for enforcing local laws; and (c) review of certain decisions made under local laws; and (d) enforcement of local laws; and (e) matters relating to legal proceedings; and (f) miscellaneous administrative matters relating to meetings, fees, abandoned goods and seized and impounded items.
Local Law No. 2 (Animal Management) 2011	 The purpose of this local law is to regulate and manage the keeping and control of animals in the local government's area in a way that— (a) balances community expectations with the rights of individuals; and (b) protects the community against risks to health and safety; and (c) prevents pollution and other environmental damage; and (d) protects the amenity of the local community and environment. The purpose is to be achieved by providing for— (a) the regulation of the keeping of animals in terms of how many, what type, how, and where animals can be kept; and (b) the prescription of minimum standards for keeping animals; and (c) the proper control of animals in public places and koala conservation areas; and (d) the management of dangerous or aggressive animals other than dogs;1 and (e) the seizure and destruction of animals in certain circumstances; and (f) the establishment and administration of animal pounds.
Local Law No. 3 (Community and Environmental Management) 2011	 (1) The purpose of this local law is to protect the environment and public health, safety and amenity within the local government's area. (2) The purpose is to be achieved by providing for the elimination or reduction of risks and threats to the environment and public health, safety and amenity resulting from (a) inadequate protection against animal and plant pests; and (b) vegetation overgrowth; and (c) visual pollution resulting from accumulation of objects and materials; and (d) fires and fire hazards not regulated by State law; and (e) community safety hazards; and (f) noise that exceeds noise standards
Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011	 (1) The purpose of this local law is to— (a) protect the health and safety of persons using local government controlled land, facilities, infrastructure and roads; and (b) preserve features of the natural and built environment and other aspects of the amenity of local government controlled land, facilities, infrastructure and roads. (2) The purpose is to be achieved by providing for— (a) the regulation of access to local government controlled areas; and (b) the prohibition or restriction of particular activities on local government controlled areas or roads; and (c) miscellaneous matters affecting roads.
Local Law No. 5 (Waste Management) 2018	(1) The purpose of this local law is to protect the public health, safety and amenity related to waste management by— (a) regulating the storage, servicing and removal of waste; and (b) regulating the disposal of waste at waste facilities; and (c) ensuring that an act or omission does not result in— (i) harm to human health or safety or personal injury; or (ii) property damage or loss of amenity; or (iii) environmental harm or environmental nuisance

Subordinate Local Law No. 3 (Community and Environmental Management) 2011	 The purpose of this subordinate local law is to supplement Local Law No. 3 (Community and Environmental Management) 2011, which provides for protecting the environment and public health, safety and amenity within the local government's area. The purpose is to be achieved by providing for— (a) declaration of local pests; and (b) prohibition of lighting or maintaining certain fires; and (c) declaration of fire hazards; and (d) declaration of community safety hazards; and (e) prescribed requirements for owners of land containing community safety hazards; and (f) declaration of noise standards.
Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011	 The purpose of this subordinate local law is to supplement Local Law No.4 (Local Government Controlled Areas, Facilities and Roads) 2011 in order to protect the health and safety of persons using local government controlled land, facilities, infrastructure and roads and preserve features of the natural and built environment and other aspects of the amenity of local government controlled land, facilities, infrastructure and roads. The purpose is to be achieved by providing for— (a) the regulation of access to local government controlled areas; and (b) the prohibition or restriction of particular activities in local government controlled areas or roads.
