The local government must decide whether or not to agree to a superseded planning scheme request within the period prescribed by, or extended as required under, the regulation. The local government must, within five business days after making the decision, give a decision notice to the person who made the suspended planning scheme request.

If the local government decides to agree, or is taken to have agreed, to a request, the superseded planning scheme application must be made within six months after the local government gives a decision notice to the person who made the request, or is taken to have agreed to the request.

If the local government decides to agree, or is taken to have agreed, to a request, the superseded planning scheme application may be made for prohibited development, despite section 50(2) of the *Planning Act 2016*.
