The owner, by accepting the above conditions hereby indemnifies the Scenic Rim Regional Council against any claim, action or process for damage or injury which might arise during the progress of the work and shall keep indemnified the Scenic Rim Regional Council against any claim, action or process for damage and/or injury which might arise from the existence of the pipes.

This authority may be withdrawn by the Scenic Rim Regional Council at any time by giving thirty (30) days' notice in writing and if so required by the Scenic Rim Regional Council, the owner shall remove the pipes at his own expense. If the owner fails to remove the pipes within the time specified, the Scenic Rim Regional Council may cause the pipes to be removed and recover the cost from the owner.
