## Risk Management Maturation Entry - Scenic Rim Regional Council

#### **Executive Summary**

The Scenic Rim Regional Council is committed to delivering a comprehensive, robust and effective Risk Management Framework. The Scenic Rim Regional Council appreciates the need for continual improvement and takes steps to ensure the Risk Management Framework is embedded, integrated and regularly reviewed to ensure it is having the desired outcome. The steps Council has implemented to ensure the Risk Management Framework is robust and minimises potential risks directly contributes to the Local Government Mutual Liability scheme by exercising control over the management of legal liability exposures confronting the Scenic Rim Regional Council.

The Scenic Rim Regional Council has previously demonstrated dedication and commitment to continuous improvement and innovation as outlined in the previous recognition of risk maturation in 2014 which included a detailed development of Level 3 Risks than previously undertaken and migration of risks to an integrated digital platform,.

#### **Background**

The Scenic Rim Regional Council commenced its journey to having a dedicated and focussed approach to managing risk in 2008. This was following its formation in 2008 following an amalgamation, as a consequence of significant local government reform, where several previous local government areas (Shire of Boonah, the southern part of Shire of Beaudesert and the Harrisville and Peak Crossing areas from the City of Ipswich) with histories extending back to the early 1900s and beyond were amalgamated. The Scenic Rim Regional Council consists of 6 divisions with one councillor per division and a mayor.

#### **Risk Maturation**

Council's risk management framework has progressively matured over the past 10 years, with a dedicated continual improvement approach to ensure the framework remains agile in meeting the organisational risk requirements. To date, Council's most notable achievements in the risk management space identified as they align to the AS/NZS ISO 31000: 2009 Principles (soon to be updated to the new Standard 31000:2018) are outlined in Appendix A.

## **Risk Integration**

Scenic Rim Regional Council is committed to ensuring risk management is integrated into business process and decision making. This is evident through several initiatives Council has adopted, including but not limited to the inclusion of the identification of relevant strategic risks and a risk assessment of identified risks on meeting agenda papers for all Executive Level and Council meetings.

#### Risk Assessments for Executive Team and Council Meeting Agenda Items

The implementation of Strategic Risk identification and Risk Assessments into Council's meeting report structure has been a highly effective way of ensuring Directorates are considering the risks of all items submitted to the Executive and Council. This process also ensures risk is factored into the decision making process when considered by the Executive Team and Council.

#### Formation of the quarterly Risk Reference Group

What this group does is review current and emerging risks in the presence of the CEO and other key decision-makers on a quarterly basis. External advisors are also invited to attend to provide input eg. JLT Regional Risk Co-ordinator, Fran Gilbert and others

## **Risk Innovation and Continuous Improvement**

In line with our previous practise of conducting Risk Review workshops to improve our risk maturity, it was decided to hold another Enterprise Risk Management workshop on the 9 March 2018. This time, Council's Senior Executive Team decided to extend the invitation to our Elected members to improve their understanding of risk matters and reinforce the "tone from the top". In addition to the Mayor and a number of Councillors, the Workshop was attended by Council's senior executive team members, our JLT Regional Risk Coordinator Fran Gilbert and JLT Senior Risk Consultant Nick Rossmann, and externally facilitated by JLT Principal Risk Services Eddie Stewart.

The focus of this Workshop was to provide an opportunity to re-focus on risk management, to incite refreshed energy and innovation when considering how the Council views risk management and what further improvements could be adopted. Furthermore, the Workshop provide an opportunity to have dedicated time to focus purely on risk management, without the everyday distractions and interruptions and allowing for an open forum to raise ideas and thoughts on how well the Council is performing in this space, what could be done better. A summary of the Workshop Agenda:

- Overview of What is Risk Management and benefits expected to be achieved from a Risk Management Program
- Overview of Councils current Corporate Wide Risks
- Overview of what are Strategic Risks
- Overview of what is Risk Appetite and associated Risk Appetite Statements
- Review Council's current 36 Corporate Wide Risks
- Develop Council's Risk Appetite
- Develop Risk Appetite Statements for each of the respective major Risk Categories

The Workshop focussed on the risk management framework and considered Council's approach to managing risk, ensuring its relevancy and currency within the current environment. A key output of the Risk Workshop was the agreement of the Council's risk appetite including risk appetite statements for critical business areas across the organisation. The Scenic Rim Regional Council Risk Appetite Table, a key output of the Workshop, is provided at <a href="#example-color: red;">Appendix C</a>.

Based on the outcomes of this latest workshop, it is Council's intention to continue to refine and modify our risk statements, ratings and controls on a quarterly basis, and to monitor and re-visit our Risk Appetite statements and other key documents at appropriate intervals.

By rolling out a risk-aware culture throughout the organisation, we envisage a safer community through the prevention of incidents, better responses when they do occur, and ultimately a reduction in insurance costs over the longer term.
